Abstrak

These verses emphasize the importance of humility and selflessness in Christian courtship as well as in relationships in general (Rogerson, 2017; Simanjuntak, 2021). The historical background and literary style of the passage explore the significance of the text for Christians today. In Philippians 2:3-4, Paul emphasizes the importance of putting others' needs before our own. The book of Philippians was written by the Apostle Paul to the church in Philippi, a city in Macedonia. The letter was written during Paul's imprisonment and contains several exhortations and encouragements to the church in Philippi. The letter was written to a group of believers in Philippi who were facing various challenges and struggles. Paul was providing practical advice for living a life of love and service (Hwang, 2016; Keown, 2013). Philippians 2:3-4 is often interpreted as a call to selflessness and humility which are important values in any relationship. Instead, Paul encourages believers to value others above themselves, placing the needs and interests of others ahead of their own. This call to humility is central to the Christian faith and is exemplified by the life and teachings of Jesus Christ. In the context of Christian courtship, this call to humility has important implications. This involves actively listening to one another, practising forgiveness and working through conflict constructively and respectfully (Ragandang III, 2018; Reyes et al., 2019).

The call to humility is a foundational principle in Christian relationships. It involves putting the needs of others before our own and recognizing that we are not the centre of the universe. This call to humility is rooted in the example of Christ himself, who "made himself nothing by taking the very nature of a servant being made in human likeness" (Philippians 2:7).
